

Privacy statement for HATTELAND TECHNOLOGY AS

Dear customer and visitor to our website. It is important to us that you can trust that all your personal information is safe with us. HATTELAND TECHNOLOGY AS spend a lot of time ensuring that your and your customers' privacy is protected and safeguarded. We use Adminkit so that we have the opportunity for an accurate and conscientious assessment of how we use your personal information.

All personal data we hold on you is data you've given us yourself. This could also include data we've received from public organisations, in order to deliver the services you are entitled to. We use no other data than is strictly necessary to carry out our work. We don't share your personal data with anyone other than our suppliers, who need this data to carry out their duties towards you, and to public organisations that request access to your data. In such cases, your data is secured by our data processing agreement. We don't keep your details for any longer than is necessary.

Your rights.

- The right to see your personal data
- The right to ask for corrections. If something is wrong, we'll correct this.
- The right to be deleted. This can be affected by our duties in relation to the accounting law, as we aren't able to delete information before we've carried out our duties

- The right to data portability. Do you wish to move your personal data? We can arrange this
- The right to protest. If you disagree with how we use your data, then let us know
