

REACH Declaration

Hatteland Technology AS confirms that all articles/products supplied, manufactured, or imported by us comply with **Regulation (EC) No 1907/2006 (REACH) (Registration, Evaluation, Authorization, and Restriction of Chemicals)**, and the Hatteland Technology specific requirements. This declaration outlines the obligations applicable to our products and their requirements.

Hatteland Technology has evaluated supplier information, certifications, material composition declarations, internal and external audits, and internal specifications.

Based on this, the following applies:

Article 7 - Registration and notification of substances in articles: If an article contains an SVHC above 0,1% weight by weight (w/w) and the total amount of that substance in all articles produced or imported exceeds 1 tonne per year, the supplier must notify ECHA.

With reference to the SVHC, candidate substances contained in Hatteland Technology products shipped into the EU do not exceed one metric tonne per year, and annual reporting to ECHA is not required. To the best of our knowledge and belief, we have determined that our products do not intentionally release substances under normal and reasonably foreseeable conditions of use.

Article 33 - Duty to communicate information on substances in articles (EU/EEA): Article 33 requires suppliers of articles to inform the recipient and consumers if a purchased article contains more than 0,1% weight by weight (w/w) of any substance(s) on the Candidate List of SVHC in the European market and provide sufficient information to allow safe use of the article.

If any products contain SVHCs above the threshold, recipients will be informed, and specific information will be provided upon request. A request can be submitted to cusforms@hattelandtechnology.com or via a designated sales representative.

SVHC Candidate list, last updated: November 5, 2025 (*Updated regularly*).

Number of substances on the SVHC Candidate list: 251.

Article 9 of 2008/98/EC with amendments (Waste Framework Directive – SCIP): Where required, Hatteland Technology submits SCIP notifications for articles containing SVHCs above 0.1% (w/w) in accordance with the Waste Framework Directive.

Article 55 - Aim of authorisation and considerations for substitution: Hatteland Technology continuously works towards substitution of substances in the SVHC list where feasible.

Annex XIV - List of Substances Subject to Authorisation: Articles containing EU REACH Annex XIV Substances Subject to Authorization shall not be placed on the market after their sunset date unless authorization has been obtained.

Based on available information, no substances subject to Annex XIV restrictions are present in our products, nor are any placed on the market after their sunset date without authorization.

Annex XVII - Restricted Substances under REACH: Based on available information, Hatteland Technology products do not contain any substances listed under REACH Annex XVII in concentrations that would trigger regulatory limitations.
